RESOLUTION REQUESTING THE HONORABLE BLAS F. OPLE, SENATE OF THE REPUBLIC OF THE PHILIPPINES, MANILA TO PLEASE ASSIST THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE CONSTRUCTION OF BARANGAY ROAD CONNECTING POBLACION TO BARANGAY BALATASAN

"WHEREAS, Section 1 of Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities income and wealth, a sustained increase in the amount of goods and services produced by the nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;

"WHEREAS, the construction of Balatasan Barangay Road will mean an easier shipment of farm produce, enhance the value of the farmers products and open the floodgates for further development;

"WHEREAS, the assistance of one of the most illustrious senators in the realization of this barangay road would make a lasting imprint among the people of this municipality;

"WHEREAS, said assistance, taking into account that this Municipality is one of the 150 Low Income Municipalities (Pro-Poor) under Proclamation No. 390, will be of great importance in the implementation of programs that are geared for the "people-powered" development in the countryside;

WHEREFORE, upon motion duly seconded, be it:

RESOLVED TO REQUEST, as it hereby requests the Hon. Blas F. Ople, Senate of the Republic of the Philippines, Manila, to please assist the Municipality of Bulalacao, Oriental Mindoro in the construction of barangay road connecting Poblacion to Balatasan;
