RESOLUTION REQUESTING THE HONORABLE RAMON B. REVILLA, SENATE OF THE REPUBLIC OF THE PHILIPPINES, MANILA TO ASSIST THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE CONSTRUCTION OF FARM TO MARKET ROAD CONNECTING POBLACION TO BARANGAYS OF BAGONG SIKAT, CABUGAO, SAN ISIDRO AND MILAGROSA

"WHEREAS, Section 9, Article 11 of the Constitution of the Republic of the Philippines, provides that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

"WHEREAS, it is imperative that employment generating programs be given top priority and that funds be allocated to rural based projects such as communal, farm to market roads, water supply etc. in order to achieve a " people-powered " development;

WHEREAS, the Municipality of Bulalacao, Oriental Mindoro needs farm to market roads to facilitate the transportation of our people's agricultural products, primarily: garlic, mango, cashew, corn, rice and many others;

"WHEREAS, almost all the inhabitants of ~~Barangay~~ Milagrosa, Bagong Sikat, Cabugao and San Isidro are relying to farming as their means of livelihood and as such live under the poverty level set by the government, thus very susceptible to the propaganda of the enemies of the State;

"WHEREAS, this Municipality, being one (1) of the Low Income Municipalities (Pro-Poor) under Proclamation No. 390, is in direful needs of financial support in order to carry out its basic programs that spell out the vision of development for the rural sector;

WHEREFORE, upon motion duly seconded, be it:

RESOLVED TO REQUEST as it hereby requests the Honorable Ramon B. Revilla, Senate of the Republic of the Philippines, Manila to assist the Municipality of Bulalacao, Oriental Mindoro in the construction of farm to market roads connecting Poblacion to barangay of Bagong Sikat, Cabugao, San Isidro and Milagrosa;

RESOLVED FURTHER, that copies of this Resolution be furnished Hon. Ramon B. Revilla, Philippine Senate, Manila for his information, consideration and kindest approval.
