
NOW, THEREFORE, on motion of Kagawad Emilio T. Gregorio, duly seconded by Kagawad Leodigario Gonzales, be it;


RESOLVED, FURTHER, that a copy of this resolution be furnished, the Municipal Treasurer, this municipality for his information and ready reference. .




