ORDINANCE NO. 93-10-057

IMPOSING TAX AND OTHER CHARGES TO ALL OPERATORS, MANAGERS OR OWNERS OF BUSES, PASSENGER JEEPNEYS AND CARGO VEHICLES PLYING REGULARLY AT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The following taxes and charges are hereby imposed to all operators, managers or owners of buses, passenger jeeps and cargo vehicles plying regularly at the Municipality of Bulalacao, Oriental Mindoro, to wit:

A. Bus	- Mayor's Permit	-	₱ 150.00
	Business Tax	-	400.00
	Miscellaneous	-	50.00
B. Passenger Jeeps	- Mayor's Permit	-	150.00
	Business Tax	-	300.00
	Miscellaneous	-	50.00
C. CARGO VEHICLES	- Mayor's Permit	-	150.00
	Business Tax	-	350.00
	Miscellaneous	-	50.00

SECTION 2. Any violation of the provision of this Ordinance shall be punished, upon conviction, by a fine of not less than One Thousand Pesos (₱1,000.00) but not more than Two Thousand and Five Hundred Pesos (₱2,500.00) or by an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court.

SECTION 3. All Ordinances inconsistent hereof are hereby repealed, modified accordingly.






SECTION 4. This Ordinance shall take effect ten (10) days after its posting.


