"RESOLUTION NO. 97-04-070

REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR TO ALLOCATE THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) FOR THE REHABILITATION OF BENLI ELEMENTARY SCHOOL BUILDING AT BARANGAY BENLI, BULALACAO, THIS PROVINCE

"WHEREAS, education is essential to nation building as acknowledged by Section 17, Article 11 in the Declaration of State Policies of the Constitution which provides and that the State shall give priority to education, science and technology, arts, culture and sports to foster patriotism, nationalism and development. It further provides that the State shall assign the highest budgetary priority to education and that quality education be made available to all;

"WHEREAS, the Elementary School Building at Barangay Benli, Municipality of Bulalacao appeared to be inconvenient and unsuitable for a conducive learning of the pupils because of the dilapidated building structure;

"WHEREAS, in order to protect the interest of the pupils and of the parents in Barangay Benli, the rehabilitation and improvement of the school building shall be of great importance; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable Rodolfo G. Valencia, Provincial Governor to allocate the amount of One Hundred Fifty Thousand Pesos (P150,000.00) for the rehabilitation of Benli Elementary School Building at Barangay Benli, Bulalacao, this Province,
