EARNESTLY REQUESTING THE HONORABLE GLORIA MACAPAGAL ARROYO, VICE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND CONCURRENT SECRETARY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF FOUR (4) UNITS OF DAY CARE CENTERS FOR THE BARANGAYS OF NASUCOB, SAN JUAN, BAGONG SIKAT AND POBLACION, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Article I of Presidential Decree No. 603, recognizes the child as one of the most important assets of the nation, so that every effort should be exerted to promote his welfare and enhance his opportunities for a useful and happy life;

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro cognizant of the need to boost literacy in the countryside, includes education among its priority programs in which the provision of the Day Care Centers at the abovementioned barangays is believed to be the most ready and suitable instrument for children aged below six years old in preparation for the next higher education ahead of them;

"WHEREAS, the provision of a Day Care Center would likewise give the children the right place to develop and promote their physical, moral spiritual, intellectual and social well-being;

"WHEREAS, the above noble objectives would only be realized through the much valued assistance of the benevolent Vice President and Secretary, the Honorable Gloria Macapagal Arroyo; Now, therefore, be it
