AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY, CALAPAN CITY TO PURCHASE RICE ON CREDIT FOR THE RELIEF OPERATION OF THE FORMER WHENEVER A STATE OF CALAMITY IS DECLARED WITHIN THE AREA

"WHEREAS, the National Food Authority (NFA) is the government agency tasked to ensure the nation with adequate and sufficient supply and distribution of rice;

"WHEREAS, in order to provide immediate assistance to its constituents in times of emergency, the Municipal Government of Bulalacao, Oriental Mindoro through the Local Chief Executive is entering into a Memorandum of Agreement with NFA to purchase rice on credit for its relief operation during a state of calamity;
