EARNESTLY REQUESTING THE HONORABLE ROBERT JAWORSKI, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY AMOUNT FOR THE CONSTRUCTION OF SCHOOL BUILDINGS FOR NASUCOB ELEMENTARY SCHOOL AND CAMBUNANG ELEMENTARY SCHOOL BOTH AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO.

“WHEREAS, it is made known to this body that the priority program of the Senator Robert Jaworski includes the construction of school buildings, water system development and farm to market roads;

“WHEREAS, it is observed that Nasucob and Cambunang Elementary Schools are in dire need of additional classroom buildings to house and accommodate the increasing enrollees;

“WHEREAS, it is also necessary to replace the old and dilapidated classroom buildings in order to protect the safety of both the teachers and pupils and the security of school properties especially during the rainy season;

"WHEREAS, it is believed that quality education ensures all possible conditions for the fullest development of the pupils given the right opportunities and enough facilities to achieve educational goals; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Robert Jaworski, Senator, Republic of the Philippines to allocate the necessary amount for the construction of two classroom buildings for Nasucob Elementary School and Cambunang Elementary School both at the Municipality of Bulalacao, Province of Oriental Mindoro;
