agriculture;


"WHEREAS, seeing this problem and in order to increase yields and productivity in

of the good Secretary Leonardo Q. Montemayor, Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Honorable

Municipality of Bulalacao, Province of Oriental Mindoro;


