JEROME DELA ROSA, DISTRICT ENGINEER, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, ROXAS, ORIENTAL MINDORO TO CONDUCT OCULAR INSPECTION ON THE DEFECTS AND IRREGULARITIES OF THE CONSTRUCTION OF TAMBANGAN, CAWACAT AND CORING-OT BRIDGES ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AND TO TAKE APPROPRIATE ACTION THEREOF

"WHEREAS, it is sadly observed that Tambangan, Cawacat and Coring-ot Bridges all of the Municipality of Bulalacao, this Province were left by its contractors without it completely finished;

"WHEREAS, various defects and irregularities on the construction of the three bridges mentioned above have been observed by the residents and this brought the feeling of dissatisfaction and discontentment among them, afraid of the consequences that may occur brought about by these irresponsible contractors;


"WHEREAS, in order to avoid further damage to lives and properties, there is a need to conduct ocular inspection on the three bridges mentioned above so that immediate and appropriate action may be made; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request Engr. Jerome dela Rosa, District Engineer, Department of Public Works and Highways, Roxas, Oriental Mindoro to conduct ocular inspection on the defects and irregularities of the construction of Tambangan, Cawacat and Coring-Ot bridges all of the Municipality of Bulalacao, Province of Oriental Mindoro and to take appropriate action thereof;
