RESOLUTION NO. 01-03-042

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2001  
OF BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO  
APPROPRIATING THE AMOUNT OF FIVE HUNDRED FIFTY TWO  
THOUSAND FIVE HUNDRED NINETY FIVE PESOS AND EIGHTY ONE  
CENTAVOS (552,595.81) PASSED UNDER SANGGUNIANG BARANGAY  
APPROPRIATION ORDINANCE NO. 1, DATED FEBRUARY 9, 2001

'WHEREAS, Section 57 and Section 447 par (li) empower the

not to be inconsistent with the law or municipal ordinance;

'WHEREAS, the Sangguniang Barangay of Milagrosa, Bulalacao,  
Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2001  
showing therein the sources of income and barangay expenditures starting from  
January 1, 2001 up to December 31, 2001;


'WHEREAS, the Barangay Fund Annual Budget for FY 2001 of  
Barangay Milagrosa was duly taken up by the Sangguniang Bayan of Bulalacao,  
Oriental Mindoro in the regular session held on March 12, 2001 and was found to

barangay with the advice that all projects funded under the 20% Development  
Fund be implemented and should not be realigned to any other projects;


'WHEREAS, it is therefore understood that disbursement of
