"WHEREAS, it is the venue of the most loved Filipino sport, the basketball that there is a need to provide additional facilities to make it more enjoyable and exciting;


"WHEREAS, additional facilities include digital watch, speaker and transformer which are necessary during the play and lights for nighttime activities;


"WHEREAS, there is also a dire need to improve the comfort room in order to maintain sanitation and cleanliness inside the gym; Now, therefore, be it


