ORDINANCE NO. 08-11-92

IMPOSING ENVIRONMENTAL USER'S FEE IN THE AMOUNT OF FIFTEEN PESOS (PHP15.00) PER SACK OF CHARCOAL TO ALL SHIPPERS OF CHARCOAL TRANSPORTING SAID MERCHANDISE OUTSIDE THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There shall be collected an environmental user's fee in the amount of Fifteen Pesos (Php15.00) per sack to all shippers of charcoals transporting said merchantile outside of the Municipality of Bulalacao, Oriental Mindoro;

SEC. 2. The fee imposed herein shall be paid to the Municipal Treasurer or his duly authorized representative upon application for Mayors Certification attesting that the charcoals to be transported were produced at the Ulingan Centers; Provided, however that the collected fees shall be deposited into a general fund wherein 50% of which shall be specifically allocated for community based forestry programs/projects including but not limited to social forestry programs; control of communal forest; establishment of tree parks; green belts; forest development projects; and creation of environmental management systems; the remaining 50% shall be allocated for support to education programs and projects;

SEC. 3. The Office of the Municipal Mayor thru the Bantay Gubat Task Force shall keep a registry of all the transport/shipments made by legal permittees indicating therein the name of permittee, transport vehicle together with its number of plate, point of origin and address of the operator as well as the number of the official receipts issued thereof.

SEC. 4. Penalty. Any violation of the provisions of this Ordinance not herein otherwise covered by a specific penalty, or of the rules and regulations promulgated under authority of

this Ordinance, shall be punished by a fine of not exceeding Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not exceeding Six (6) months, or both at the discretion of the Court


SEC. 5. Separability Clause. If for any reason, any provisions, sections or part of this Ordinance is held invalid or unconstitutional, the same shall not affect the rest of its provision.

SEC. 6. Repealing Clause. All ordinances inconsistent hereof are hereby repealed, modified accordingly.


SEC. 7. Effectivity. This Ordinance shall take effect ten (10) days after its posting.

ENACTED this 17th day of November, 2008, Bulalacao, Oriental Mindoro.






