### RESOLUTION NO. 10-10-098

EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO C. AQUINO, III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES TO INCLUDE THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES (CIDSS) PROJECT WHICH IS PART OF THE UNITED STATES MILLENNIUM CHALLENGE CORPORATION (MCC) ASSISTANCE TO THE PHILIPPINES AIMED TO REDUCE POVERTY

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 whose population is approximately composed of twenty percent hanunuo mangyans who because of poverty could hardly cope up with their daily basic needs;

"WHEREAS, hounded with financial constraints, the Local Government Unit of Bulalacao, Oriental Mindoro could not readily implement programs and projects needed to uplift the social and economic status of the residents and the community that assistance from the Office of the President is believed to be the only hope for this poor town to improve;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro needs various infrastructural projects such as construction of farm to market roads, construction of school buildings, construction of water system, livelihood projects for the marginal farmers and fishermen, mangrove plantation and reforestation projects;

"WHEREAS, it is likewise sad to see that Bulalacao is devastated with trees and other species of flora and fauna brought by illegal logging and charcoal making, kaingin system and other illegal activities which resulted to drought and uncontrollable flood during rainy season that destroy lives and properties;


