EARNESTLY REQUESTING DIRECTOR EMMANUEL H. ASIS, OIC-REGIONAL DIRECTOR, BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGION IV-B TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF FISH CAGE IN THE DESIGNATED MUNICIPAL WATERS IDENTIFIED BY THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

**"WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is a modest town that relies partly on fishing as a means of livelihood;

**"WHEREAS**, several strategies come up to uplift the lot of our marginal fisherfolks that the idea of developing the potentials and abilities such as the establishment of fish cages within the areas identified is one of the options that the Bureau of Fisheries and Aquatic Resources (BFAR) saw as an alternative method of raising various agro-marine products such as fish and others;

**"WHEREAS**, the Municipality of Bulalacao knowing that BFAR is putting weight on this kind of support to our people where many of them rely on fishing, this Sanggunian hereby requests the proper authority, specifically the BFAR to put-up fish cages in our designated municipal waters as a source of income to our marginal fisherfolks; Now, therefore, be it


