RESOLUTION NO. 09-06-087

EARNESTLY REQUESTING THE HONORABLE JOSELITO ATIENZA, SECRETARY, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) TO FACILITATE THE IMPLEMENTATION OF THE AGRO-FORESTRY PROGRAM IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 26 of RA 7160, also known as the Local Government Code of 1991, provides that "it shall be the duty of every national agency or government-owned or controlled corporation authorizing or involved in the planning and implementation of any project or program that may cause pollution, climate change, depletion of non-renewable resources, loss of crop land, range-land, or forest cover, and extinction of animal or plant species, to consult with the local government units, non-governmental organizations, and other sectors concerned and explain the goals and objectives of the project or program, its impact upon the people and the community in terms of environmental or ecological balance, and the measures that will be undertaken to prevent or minimize the adverse effects thereof";

"WHEREAS, corollary with the above, Section 17, par 2 (ii) of the same law further provides that the Municipality shall exercise powers and discharge duties pursuant to national policies and subject to supervision, control and review of the DENR implementation of community-based forestry projects which include integrated social forestry program and similar projects; management and control of communal forests with an area not exceeding 50 square kilometers; establishment of tree parks, green-belts, and similar forest developing projects;

"WHEREAS, big portion of land in this Municipality is characterized of hilly, rolling and upland areas suitable for Agro-Forestry Program;

"WHEREAS, the wanton disregard to environmental protection and conservation have resulted to rapid denudation of the remaining forestal areas of this town;


"WHEREAS, the implementation of Agro-Forestry Program was designed to restore the ecological balance of nature; hence, improving the quality of life of the inhabitants thereof and; consequently save and protect our forest areas from further destruction and irresponsible exploitation; Now, therefore, be it
