EARNESTLY REQUESTING THE HONORABLE SANGGUNIANG PANLALAWIGAN MEMBERS THROUGH THE HONORABLE HUMERLITO A. DOLOR, VICE GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO INTERVENE IN THE IMMEDIATE FIXING OF EXACT BOUNDARIES BETWEEN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AND THE MUNICIPALITY OF MAGSAYSAY, OCCIDENTAL MINDORO AND TO CONSTRUCT A LANDMARK BETWEEN THE TWO PROVINCES

"WHEREAS, it is happy to see that after so many years, the Bulalacao to San Jose, Occidental Mindoro Circumferential Road is now open for traffic that facilitate the easier transfer of people and shipment of goods that propel business activities geared towards economic development of both provinces;

"WHEREAS, there is a need to determine the exact area of territorial jurisdiction between the Municipality of Bulalacao, Province of Oriental Mindoro and the Municipality of Magsaysay, Province of Oriental Mindoro in order to avoid any possible boundary disputes in the future, particularly in the delivery of basic social services to the residents living at the boundary areas;

"WHEREAS, the fixing of exact boundaries between the abovementioned municipalities would definitely lead to the stability of the social and economic conditions of the residents living in these two towns and would likewise trigger the implementation of various developmental projects at their respective territory; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Sangguniang Panlalawigan Members through the Honorable Humerlito A. Dolor, Vice Governor, Province of Oriental Mindoro to intervene in the immediate fixing of exact boundaries between the Municipality of Bulalacao, Province of Oriental Mindoro and the Municipality of Magsaysay, Occidental Mindoro and to construct a landmark between the two provinces;


