"WHEREAS, the Municipality of Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, Bulalacao, a 3rd class municipality is a vast agricultural land, has 15 barangays with a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector, it is producing large volume of rice, corn, garlic and onions and varieties of fruits and vegetables transported to nearby towns and provinces and even in Metro Manila that sufficient supply of water is direly needed to sustain its growth and production;

"WHEREAS, the effects of the El Niño phenomenon are evident in Bulalacao, it brought remarkable losses in the livelihood of its people especially in the agricultural sector, having financial constraints it is a challenge for its Local Government to provide and sustain the needs and assistance of the community whenever this kind of calamity occurs;


"WHEREAS, to aid the water supply problem of the Bulalacaonon farmers, it is favorable to have a portable drilling machine for irrigation purposes that can certainly ensure uninterrupted discharge of water especially during this dry season;


