RESOLUTION REQUESTING THE PROVINCIAL GOVERNOR HUMERLITO "BONZ" A. DOLOR TO PROVIDE NECESSARY MEDICAL EQUIPMENT AND MEDICAL SPECIALISTS IN THE ORIENTAL MINDORO SOUTHERN DISTRICT HOSPITAL LOCATED AT ROXAS, ORIENTAL MINDORO IN ORDER TO BE CONSIDERED AS LEVEL I HOSPITAL

"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as health services which include hospitals and other tertiary health services;

"WHEREAS, the Oriental Mindoro Southern District Hospital is a secondary hospital located at Roxas, Oriental Mindoro that caters quality and affordable medical care and services for the people of 2nd District of Oriental Mindoro;

"WHEREAS, most of the indigent patients of the Bulalacao Community Hospital who are needing extensive medical treatment are being referred to Oriental Mindoro Provincial Hospital in Calapan City to aid their medical needs and emergencies, however there are reports that most of them were being rejected because the hospital was always full and could not accommodate patients from other municipalities;

"WHEREAS, this Sanggunian believes that the solution for this is that the nearest secondary hospital which is the Oriental Mindoro Southern District Hospital shall have additional medical equipment and medical specialists to be considered as Level I hospital that will provide advanced medical care and treatment to the ailing patients of the 2nd District of the province; Now, therefore, be it...






