RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO ASSIGN AND TURN-OVER CREATIVE ASSETS AND MATERIALS OF THE LGU TO THE DEPARTMENT OF TOURISM AND TO SIGN A WAIVER OF LIABILITY

"WHEREAS, to guarantee ownership and warrant the authenticity of the creative assets by the LGU-Bulalacao and to grant authority to DOT for the use of the creative assets, there is a need to execute a consent to use creative video and other creative assets for promotional purposes to the Department of Tourism and Waiver of Liability.

"WHEREAS, this Sanggunian finds the subject consent to use photos, video and other creative assets for promotional purposes to the Department of Tourism and Waiver of Liability in order pursuant to the provisions of Section 455, Paragraph (b)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the LGU-Bulalacao all its business, transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance. Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED TO: Authorize Engr Emilio C. Villas, Municipal Mayor to represent the Local Government Unit of Bulalacao, Oriental Mindoro to assign and turn-over creative assets and materials of the LGU to the Department of Tourism and to sign a waiver of liability.
