RESOLUTION EARNESTLY REQUESTING THE OFFICE OF THE NATIONAL CIVIL DEFENSE AND NDRRMC TO ALLOCATE THE NECESSARY FUND FOR THE REHABILITATION/CONSTRUCTION OF SEAWALL OR BREAKWATER AT BARANGAYS MILAGROSA, BULALACAO, ORIENTAL MINDORO

“WHEREAS, the town of Bulalacao, a coastal municipality of the Province of Oriental Mindoro was not spared from the havoc incurred from the onslaught of Super Typhoon Yolanda;

“WHEREAS, Milagrosa, being a coastal barangay had already seen the possibility of the dangers from large swells or storm surge that might hit the populated area which houses were built along the stretch of shorelines, that it put up a seawall or breakwater;

“WHEREAS, had it not for the existence of the constructed seawall chances were that the barangay should have been wiped-out as large swells penetrated the wall; however it reduced the possible magnitude of damage;


