"WHEREAS, the Municipality Bulalacao is well-nigh to being an eco-agro-tourism destination in MIMAROPA Region, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, the PhilCarbon Inc. previously did a wind measurement for the wind power development in the bay of Bulalacao along Barangay Milagrosa, however there was no update since then that the area being granted remains underdeveloped and there is no any progress in its wind power project;

"WHEREAS, most recently the CleanTech Global Renewables Inc., a Filipino-owned renewable energy developer showed its interest to continue the wind power development project in the Municipality of Bulalacao, it teamed up with Singapore-based company, The Blue Circle and signed a wind energy service contract to develop a 1.2-gigawatt offshore wind project in Bulalacao;


