### **RESOLUTION NO. 14-01-005**

**A RESOLUTION EXPRESSING THE COMMITMENTS AND UNDERTAKINGS OF THE MUNICIPAL GOVERNMENT OF BULALACAO IN THE IMPLEMENTATION OF THE PERFORMANCE CHALLENGE FUND (PCF) GRANTED TO THE MUNICIPALITY**

**“WHEREAS,** the Department of the Interior and Local Government (DILG) is the Office with primary responsibility in localizing the Millennium Development Goals (MDGs) and capacitating LGUs to effectively discharge their powers and functions towards improving the delivery of basic services and facilities to their constituents;

**“WHEREAS,** the Performance Challenge Fund (PCF) for the Local Government Units is a flagship program of the DILG that serves as a facility that will help stimulate LGUs that put premium on transparency and accountability;

**“WHEREAS,** the Performance Challenge Fund (PCF) is an incentive fund to eligible LGUs to support in the implementation of high-impact capital investment projects in the Annual Investment Program (AIP);

**“WHEREAS**, the Performance Challenge Fund (PCF) is being administered by the Department of the Interior and Local Government in collaboration with the Department of Budget and Management (DBM) to recognize good governance performance particularly in the adoption of **“good housekeeping”** along the governance areas of development planning, sound financial management, transparency and accountability and valuing performance monitoring;

**“WHEREAS**, the Municipality of Bulalacao has been awarded the Seal of Good Housekeeping in 2012 thereby entitles the LGU to receive the PCF Subsidy amounting to a maximum of One Million Pesos (PhP1,000,000.00);

**“WHEREAS**, the Municipal Government of Bulalacao fully supports and commits itself to the ultimate goal of the Performance Challenge Fund which is to attain the highest degree of Good Governance in the Local Government Units;

**NOW, THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Bayan in a session duly assembled, that its Mayor, Honorable Edna C. Villas is hereby authorized and empowered for and in behalf of the Municipal Government of Bulalacao to do the following:

- (a) Support the implementation of Performance Challenge Fund;
- (b) Prepare Program of Work and undertake detailed engineering plans for the **Cultural Heritage Cum Tourism Center** being proposed for PCF funding assistance eligible under the menu of projects cited in the Memorandum Circular issued for the purpose;
- (c) Observe and comply with prescribed safeguard policies by existing Philippine laws on (1) environment, (2) involuntary resettlement for project affected persons, and (3) indigenous people;
- (d) Abide by the government procurement safeguard and anti-corruption policies and to enforce proper financial and fiduciary management.

**RESOLVED FURTHER**, That the Sangguniang Bayan of Bulalacao hereby authorizes the Municipal Mayor to undertake the following for and in behalf of the Municipality;

1. Confirm, approve and ratify all previous representations and all the terms and conditions of the Memorandum of Agreement signed between the Municipality of Bulalacao and the DILG for the implementation of PCF;
2. Enter into such other Memorandum of Agreement with other parties that may be necessary to facilitate implementation of infrastructure subprojects;
3. Enter into contracts for civil works, consultancy, equipment and other agreements required in the implementation of the PCF.


**RESOLVED FINALLY**, To furnish the Office of the Department of the Interior and Local Government (DILG) with a copy of this resolution.




