RESOLUTION NO. 13-02-023

RESOLUTION AUTHORIZING ATTY. KRISTINE GRACE L. SUAREZ, PROVINCIAL LEGAL OFFICER AND/OR HER DEPUTY, AND/OR THE PROVINCIAL PROSECUTION OFFICE TO REPRESENT THE MUNICIPALITY OF BULALACAO IN CIVIL CASE NO. C-566 CAPTIONED "PROVINCE OF ORIENTAL MINDORO AND MUNICIPALITY OF BULALACAO VS. PROVINCE OF ANTIQUE AND MUNICIPALITY OF CALUYA FOR RECOVERY AND DECLARATION OF TERRITORIAL AND POLITICAL JURISDICTION/DOMINION, PROHIBITION AND MANDAMUS

"WHEREAS, on 11 June 2012, the Sangguniang Panlalawigan approved Resolution No. 1557-2012 entitled "Resolution authorizing the Provincial Legal Officer, for and in behalf of the Provincial Government of Oriental Mindoro and the Municipality of Bulalacao, to institute and file the necessary legal actions for the claim of the Island of Liwagao as part of the territorial jurisdiction of the Municipality of Bulalacao, Province of Oriental Mindoro";

"WHEREAS, pursuant to said authority, Atty. Kristine Grace L. Suarez, Provincial Legal Officer, instituted the abovementioned Civil Case on behalf of the Province of Oriental Mindoro and the Municipality of Bulalacao against the Province of Antique and Municipality of Caluya in the Regional Trial Court Branch 43 stationed at Roxas, Oriental Mindoro;

"WHEREAS, considering that the heart and core of this legal battle is the recovery of territorial and political jurisdiction over the Island of Liwagao, an island which belongs, historically and legally to the Municipality of Bulalacao, Province of Oriental Mindoro, the Sangguniang Bayan of Bulalacao deemed it necessary and appropriate to authorize Atty. Kristine Grace L. Suarez and/or her deputy, and/or the Provincial Prosecution Office to represent the Municipality of Bulalacao in this legal proceeding;

"WHEREAS, the collaboration of the Provincial Prosecution Office with the Provincial Legal Officer and/or her deputy is indispensable in the speedy disposition and triumph of this case considering that Province of Oriental Mindoro and the Municipality of Bulalacao will always be assured of a legal counsel every time the case is called at any stage of the proceeding;

"WHEREAS, the Sangguniang Bayan of Bulalacao has high respect in the competency and diligence of Atty. Kristine Grace L. Suarez and/or her deputy, and the Prosecutors in the Provincial Prosecution Office, and fully believes that they could well represent the Province of Oriental Mindoro and the Municipality of Bulalacao in the abovementioned case;

"WHEREAS, given this authority, it is expected that Atty. Kristine Grace L. Suarez and/or her deputy and the Provincial Prosecution Office shall submit report to the Sangguniang Bayan regarding any development in the case together with their recommendation, if any, on pressing issues requiring immediate action from this August Body;








