RESOLUTION NO. 13-02-022-A

RATIFYING THE RULES AND REGULATIONS GOVERNING THE IMPLEMENTATION OF RA NO.10172 OTHERWISE KNOWN AS AN ACT FURTHER AUTHORIZING THE CITY OR MUNICIPAL CIVIL REGISTRAR OR THE CONSUL GENERAL TO CORRECT CLERICAL OR TYPOGRAPHICAL ERRORS IN THE DAY AND MONTH IN THE DATE OF BIRTH OR SEX OF A PERSON APPEARING IN THE CIVIL REGISTER WITHOUT NEED OF A JUDICIAL ORDER, AMENDING FOR THIS PURPOSE ACT NO. 9048

“WHEREAS, RA No. 10172 amended RA No. 9048 regarding the provisions on correcting clerical or typographical errors in the day and month in the date of birth or sex of a person appearing in the civil register without need of a judicial order;

“WHEREAS, Rule I of Administrative Order No. 1, series of 2012 of Office of the Registrar General, Rules and Regulations Governing the Implementation of RA10172 authorized the Municipal Civil Registrar to correct clerical or typographical errors in the day and month (date of birth) or sex of a person in the civil register of birth;

“WHEREAS, Rule 10 of the same Administrative Order further authorized the Municipal Civil Registrar to collect filing and other fees from every petitioner the amount prescribed therein for any type of correction;

“WHEREAS, under the same Rule, the local legislative body shall ratify the fees prescribed therein upon effectivity of the Order shall go to the Local Civil Registrar Office (LCRO) trust fund, provided, however, that the fees prescribed therein shall be uniform in all cities and municipalities in the country, and in all Philippine Consulates; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Ratify the Rules and Regulation Governing the Implementation of RA No. 10172 otherwise known as An Act Further Authorizing the City or Municipal Civil Registrar or the Consul General to correct clerical or typographical Errors in the Day and Month in the Date of Birth or Sex of a person appearing in the Civil Register without Need of a Judicial Order, Amending for this Purpose Act No. 9048;






