"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center and other similar facilities;

"WHEREAS, for almost four decades the Island of Liwagao has been in the jurisdiction of the Province of Antique, however, with the declaration of the decision made by the Regional Trial Court on August 20, 2021 the island was put back its political, territorial, and administrative jurisdiction to Barangay Maasin, Municipality of Bulalacao, Province of Oriental Mindoro;


