RESOLUTION NO. 21-04-137

RESOLUTION REQUESTING GOVERNOR HUMERLITO "BONZ" A. DOLOR TO COORDINATE WITH THE PROVINCIAL GOVERNMENT OF OCCIDENTAL MINDORO THRU GOVERNOR EDUARDO B. GADIANO TO CONSIDER NEGATIVE ANTIGEN TEST INSTEAD OF NEGATIVE RT-PCR TEST RESULT AS REQUIREMENT FOR DRIVERS AND HELPERS OF TRUCKS HAULING ESSENTIAL FOOD PRODUCTS ENTERING THE PROVINCE OF OCCIDENTAL MINDORO AND VICE VERSA

"WHEREAS, pursuant to the Executive Order No. 7-A, series of 2021 of Provincial Governor Eduardo B. Gadiano effective March 25, 2021, a negative RT-PCR test result (swab or saliva) is required upon entering the Province of Occidental Mindoro with the exemptions to Authorized Persons Outside Residence (APORs) from National Government and related agencies, Local Government Officials with official business, returning patients with watchers (maximum of 2), and those who can return to the province within 72 hours;

"WHEREAS, Section 6 of Executive Order No. 16, series of 2021 of Provincial Governor Humerlito "Bonz" A. Dolor effective April 10, 2021, mandatory Rapid Antigen Testing upon arrival is required to all the travelers entering the Province of Oriental Mindoro with exemptions to the truck drivers and their helpers whose carrying goods, essential travelers that are returning to the province within 24 hours, and travelers that has negative RT-PCR test result issued 24 hours upon they travel;

"WHEREAS, in accordance to the Resolution No. 101 dated February 26, 2021 of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF), it has been approved that the uniform travel protocols for land, air and sea of the Department of the Interior and Local Government, crafted in close coordination with the Union of Local Authorities of the Philippines, League of Provinces of the Philippines, League of Municipalities of the Philippines and the League of Cities of the Philippines shall be observed;

“WHEREAS, Bulalacao is a third class municipality located at the southernmost tip of the Province of Oriental Mindoro, and is in the borderline connecting to its adjacent province which is the Occidental Mindoro;

“WHEREAS, it has been escalated that the people of Bulalacao most especially those who are into business are having a hard time in transporting their goods and products because of the negative RT-PCR requirement of its neighboring Province of Occidental Mindoro;

“WHEREAS, the struggle to make a living in this pandemic is very evident, and this Sanggunian manifests the difficulties of most Bulalacaonon to comply with the requirements of the Province of Occidental Mindoro because aside of the reason that our municipality is hounded with financial constraints, the nearest available RT-PCR test hub here is located in Calapan City where it would take hours of travel;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED To: Request Governor Humerlito “Bonz” A. Dolor to coordinate with the Provincial Government of Occidental Mindoro thru Governor Eduardo B. Gadiano to consider antigen test instead of negative RT-PCR test result as requirement for drivers and helpers of trucks hauling essential food products entering the Province of Occidental Mindoro and vice versa.
