EARNESTLY REQUESTING THE HONORABLE ERINEO S. MALIKSI, CHAIRMAN, PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) TO DONATE ONE (1) UNIT OF AMBULANCE TO THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 and whose population is composed approximately of twenty percent hanunuo mangyans who because of poverty are deprived of their basic right to health;

“WHEREAS, cognizant of the inherent right to health, the Municipal Government of Bulalacao despite of limited funds was able to establish a mini-hospital in Barangay Benli to ensure the delivery of basic health services to the mangyans;

“WHEREAS, it is likewise the top priority of the present Administration to ensure the safety of the mother and the newborn babies that three (3) building facilities were constructed but due to lack of funds only one (1) is operational;

“WHEREAS, the availability of ambulance to this Pro-Poor Municipality is direly needed because patients of serious illness and in emergency situations are brought to Calapan City of 200 kilometers in distance where modern medical facilities are available and further medical treatment are needed, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Erineo S. Maliksi, Chairman, Philippine Charity Sweepstakes Office (PCSO) to donate one (1) unit of ambulance to the Municipality of Bulalacao, Province of Oriental Mindoro;


