RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 08-12-2016 OF BARANGAY POBLACION REALIGNING THE AMOUNT OF SIXTEEN THOUSAND ONE HUNDRED EIGHTY EIGHT PESOS AND FIFTY THREE CENTAVOS (PHP16,188.53) TAKEN FROM HONORARIUM OF SANGGUNIANG KABATAAN FOR THE MONTHS OF OCTOBER TO DECEMBER 2016 TO AUGMENT FUND FOR PRODUCTIVITY ENHANCEMENT INCENTIVES (PEI)

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve Appropriation Ordinance No. 08-12-2016 of Barangay Poblacion Realigning the amount of Sixteen Thousand One Hundred Eighty Eight Pesos and Fifty Three Centavos (PhP16,188.53) taken from Honorarium of Sangguniang Kabataan for the months of October to December 2016 to augment fund for Productivity Enhancement Incentives (PEI) with the following recommendations, to wit:


1. That, the granting of PEI shall be in accordance with COA Rules and Regulations;
