### **RESOLUTION NO. 21-03-097**

**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2020-09-14, ANNUAL BUDGET FOR FY 2021 OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO ENTITLED "AN ORDINANCE APPROVING THE ANNUAL BUDGET IN THE AMOUNT OF TWO MILLION ONE HUNDRED FORTY SIX THOUSAND FOUR HUNDRED ELEVEN PESOS (PHP2,146,411.00) TAKEN FROM INTERNAL REVENUE ALLOTMENT (IRA), SHARE IN REAL PROPERTY TAX, COMMUNITY TAX, CLEARANCE AND CERTIFICATION FEES, FINANCIAL ASSISTANCE (PGOM)" OPERATIVE IN ITS ENTIRETY**

**"WHEREAS**, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2021 showing therein the estimated sources of income and expenditures starting from January 1,2021 up to December 31,2021 to this Sanggunian for review on February 9,2021 pursuant to the provisions of Republic Act (R.A.) No. 7160;

**"WHEREAS**, the Annual Budget for FY 2021 of Barangay Maasin was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on March 1,2021 and was found to be consistent with pertinent laws, rules and regulations;

**"WHEREAS,** Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;

**"WHEREAS,** it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it


