### **RESOLUTION NO. 21-02-089**

**RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE TO INSPECT AND EVALUATE THE PROPOSED CONSTRUCTION OF NAPISIAN-HAMLOY-UMABANG-BALAGWAY-BAILAN-BENLI PROPER FARM-TO-MARKET ROAD, KALONG-DACUTAN-TALISAY-BADYANG-KAPULAWAN-BASAKAR FARM-TO-MARKET ROAD; SAN FRANCISCO-SAN ISIDRO-BAGONG SILANG FARM-TO-MARKET ROAD LOCATED IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**“WHEREAS**, the Municipality of Bulalacao is a third class municipality located at the southernmost tip of the Province of Oriental Mindoro that has a distinct geographical features with a population of 39, 107 based on 2015 census, it has a tropical climate that is situated at approximately 12° 12' North, 121° 21' East;

**“WHEREAS**, Bulalacao is on its way to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**“WHEREAS**, it is important to conduct assessments of certain farm-to-market roads prior to its construction to check whether the elevations in areas of terrain possess undesirable slopes and is prone to landslide or if the landscape needs to be shaped and engineered arduously;

"WHEREAS, the construction of farm-to-market roads will be beneficial most especially to farmers in transporting their agricultural products to market, this shall promote livelihood, enhance social and economic upliftment to boost their moral by giving them enough opportunities to become active and productive members of the community;
