**RESOLUTION NO. 19-02-043**

**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2019-01 OF BARANGAY MAASIN ENTITLED "AN ORDINANCE APPROVING THE ANNUAL BUDGET CY-2019 APPROPRIATING THE SUM OF ONE MILLION EIGHT HUNDRED FORTY FIVE THOUSAND FIVE HUNDRED FORTY TWO PESOS (PhP1,845,542.00) TAKEN FROM BARANGAY IRA, REAL PROPERTY TAX, COMMUNITY TAX, CLEARANCE AND CERTIFICATION FEES, OTHER DONATION, INTEREST INCOME AND AID FROM MUNICIPAL & PROVINCIAL, OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO" INOPERATIVE IN PART**

**"WHEREAS**, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2019 showing therein the estimated sources of income and expenditures starting from January 1, 2019 up to December 31,2019;

**"WHEREAS**, the Annual Budget for FY 2019 of Barangay Maasin was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 15, 2019 and was found to be consistent and in accordance with Annual Investment Program of Barangay Maasin, with the advice that all projects funded under the 20% Development Fund be fully implemented and should not be realigned to any other projects unless completed or reprogrammed;

**"WHEREAS**, Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith;

**“WHEREAS**, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it ...

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Declare the Appropriation Ordinance No. 2019-01 of Barangay Maasin entitled “An ordinance approving the Annual Budget CY-2019 appropriating the sum of one million eight hundred forty five thousand five hundred forty two pesos (PhP1,845,542.00) taken from Barangay IRA, Real Property Tax, Community Tax, Clearance and Certification Fees, Other Donation, Interest Income and Aid from Municipal & Provincial, of Barangay Maasin, Bulalacao, Oriental Mindoro” **INOPERATIVE IN PART**, effective February 15,2019 subject to the posting requirements under Section 59 of R.A. No. 7160, and subject further to the following conditions:

1. Provide full appropriation for Year-end bonus;
2. Lump sum appropriations should be broken down to proper object of expenditures;
3. Use proper account titles and account codes per COA NGAS Revised Chart of Accounts;
4. Submit the copy of resolution approving AIP;
5. Provide sufficient funds for Gender and Development program, Senior Citizen and PWD Program for Protection of Children, program for combating AIDS, support fund for implementation of Dangerous Drugs Act;
6. Revise projects on 20% Development Fund for disallowed project.






