“WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center and other similar facilities;

“WHEREAS, Bulalacao is a third-class Municipality located at the southernmost tip of Oriental Mindoro with a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding and other damages that affect the houses and the safety of the people, and it has always been a challenge for its local government to provide temporary shelter for its residents who eminently affected by such calamities because of the lack of evacuation center;

"WHEREAS, the provision of evacuation centers at the elementary and high schools in Barangay Benli would not only be beneficial to its community but this would also convey awareness to people that the government is focused in giving welfare and infrastructural development in the countryside, thus it would support in upholding the structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...


