RESOLUTION NO. 18-02-017

RESOLUTION URGENTLY REQUESTING THE DEPARTMENT OF TRANSPORTATION (DOTr) THRU ITS SECRETARY ARTHUR P. TUGADE TO SCHEDULE THE CAPACITATION OF THE LGUs ON THE FIRST QUARTER OF 2018 PERTAINING TO THE FORMULATION OF LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP)

“WHEREAS, the Department of Transportation issued Department Order No. 2017-011, dated June 19, 2017, subject of which is the Omnibus Guidelines on the Planning and identification of Public Road Transportation Services and Franchise Issuance;

“WHEREAS, the DOTr recognizes that LGUs are in a better position to identify local public transport service requirements and formulate a local-level planning approach in line with the decentralization envisioned by RA 7160 otherwise known as the Local Government Code of 1991, which will be more effective in determining local public transport services;

“WHEREAS, the DOTr shall set the guidelines, criteria and procedures for local public transport route planning and help build local capacities to prepare LPTRPs and consequently, LTPs;

“WHEREAS, the Municipality of Bulalacao, like any other municipalities and cities, as well, shall be responsible for collecting data, analyzing public transport supply and demand, and identifying specific public transport supply gaps for travel within their territories and for capturing this in municipal transportation plans;

"WHEREAS, during the SP Committee on Transportation hearing held on January 16, 2018, it was agreed upon the LGUs should be capacitated to come up with a sound and comprehensive, LPTRP which shall be the minimum requirement prescribed for the issuance of franchises, and which shall form part of the Local Transport Plan (LTP), relating land use to transport modes and provides measures for traffic management in every LGU;

"WHEREAS, in consonance with the thrust of the Provincial Government of Oriental Mindoro toward its goal of becoming the Tourism Center of the Region, and also to promote public safety and road worthiness of the public in the entire province, this August Body deems it necessary to facilitate the capacitation of the local functionaries to be able to prepare the LPTRP and LTP; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Urgently request the DOTr thru Secretary Arthur P. Tugade to schedule the capacitation of the LGUs, specifically the Municipality of Bulalacao, on the first quarter of 2018 pertaining to the formulation of Local Public Transport Route Plan (LPTRP);

RESOLVED FURTHER, To: Furnish copy of this Resolution the Department of Transportation thru Secretary Arthur P. Tugade, for his information and most preferential attention;
