"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities, as such for barangays it includes infrastructure facilities like multi-purpose hall, multi-purpose pavement, plaza, sports center and other similar facilities;

"WHEREAS, Bulalacao, a 3rd class Municipality hounded with financial constraints which is located at the southernmost tip of the Province of Oriental Mindoro, it has a municipal government that provides adequate facilities for the physical development of the community;

"WHEREAS, Benli Covered Court is one of the recently constructed covered courts in the Municipality of Bulalacao, thus there is still a need for its improvement such as the construction of floor, stage, comfort room, fiber glass basketball board and bleacher that would be useful in any event or program of the barangay;

"WHEREAS, the improvement of the said covered court would be most beneficial for the residents for it shall serve as an evacuation center during calamities, it would also support in upholding the structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...
