EARNESTLY REQUESTING HONORABLE ANTONIO "JOJO" S. PEREZ, JR., PROVINCIAL VICE GOVERNOR TO ALLOCATE FUNDS AND FACILITATE THE CONSTRUCTION OF PROVINCIAL ROAD ALONG BAGONG SIKAT PROPER TO CABUGAO PROPER TO SAN ISIDRO TO SAN FRANCISCO, ALL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, roads are of vital importance in order to make a nation grow and develop. It provides access to employment, social, health and education services which makes a road network crucial in fighting against poverty. Roads open up more areas and stimulate economic and social development;

"WHEREAS, the four (4) barangays mentioned above are classified into a Geographically Isolated and Depressed Area (GIDA) that a provincial road connecting Barangays Bagong Sikat, Cabugao, San Isidro to San Francisco needs to be connected to facilitate movement of people and shipment of agricultural products abundant in the area;

"WHEREAS, the construction of the provincial road herein mentioned is indispensable to address the insurgency problem in those barangays and the Government believes that construction of road networks is the best counter-insurgency strategy to move them away; **Now, therefore, be it**
