RESOLUTION REQUESTING CONGRESSMAN ALFONSO V. UMALI, JR., 2ND DISTRICT REPRESENTATIVE, PROVINCE OF ORIENTAL MINDORO TO FACILITATE THE ESTABLISHMENT AND DEVELOPMENT OF BUSINESS PROCESSING OUTSOURCING (BPO) AND INFORMATION TECHNOLOGY (IT) PARK IN THE PROVINCE OF ORIENTAL MINDORO AND SUBSEQUENTLY IN THE MUNICIPALITY OF BULALACAO

"WHEREAS, Business Process Outsourcing (BPO) industry is at utmost importance in emerging the country's economy and contributes over 11% to the GDP, it is the single largest sector which employs over 1.2 million people that spread across some 700 outsourcing companies, it resorts services from a third-party provider and uses various technology-enabled operations to bundle the delivery of services;

"WHEREAS, Information Technology is a strategic industry which has been the counterbalance for the progress of developing countries such as the Philippines, it provides growth of internet use and electronic commerce, and improves our country's economic performance;

"WHEREAS, the Municipality of Bulalacao is one of the progressing municipalities of the Province of Oriental Mindoro, it is fast-approaching to be the agro-eco-tourism hub of the province, it has a very promising development in terms of infrastructures and business opportunities, and has a municipal government that provides efficient, reliable and adequate communication facilities and services and promotes growth of commercial and industrial activity in the locality;




