"WHEREAS, Bulalacao is a 3rd class municipality with a vast agricultural land, has 15 barangays and with a total agricultural land area of 10, 325.80 hectares where 6,016 individuals are employed in the agricultural sector;

WHEREAS, Bulalacao has a tropical climate type conducive to planting of staple crops such as rice, corn, onion including garlics and other varieties of vegetables and fruits transported to Manila and nearby provinces;


