"WHEREAS, Bulalacao is a 3rd class municipality with a vast agricultural land, has 15 barangays and with a total agricultural land area of 10, 325.80 hectares where 6,016 individuals are employed in the agricultural sector;

"WHEREAS, Bulalacao is composed of eight (8) coastal barangays of 58,200 hectares of municipal waters with 4,445 fisherfolks whose main source of living comes from aquaculture activities with its hydrographic conditions favoring high production such as fishing;


