“**WHEREAS**, Section 123 of Republic Act No. 8550 states that the Department of Agriculture shall authorize the National Mapping and Resource Information Authority (NAMRIA) for the designation and charting of navigational lanes in fishery areas and delineation of municipal waters;

“**WHEREAS**, Bulalacao is a third class municipality, has a municipal government that promotes proper utilization of forest land, river, marine and coastal resources, and strengthen agricultural and fishery production and uplift the life of small farmer and fishing communities;

"WHEREAS, Bulalacao, has eight (8) coastal barangays whose major source of income of the residents is fishing. It is acclaimed as the fishing capital of the Province of Oriental Mindoro transporting large volume of fish and other marine products to nearby provinces and Metro Manila;


