SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE NASSER C. PANGANDAMAN, SECRETARY, DEPARTMENT OF AGRARIAN REFORM (DAR) FOR APPROPRIATING THE NECESSARY FUNDS NEEDED FOR THE CONSTRUCTION/REHABILITATION OF FIFTEEN (15) FARM TO MARKET ROADS PROJECT AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:




SEC. 3. This Special Ordinance shall take effect immediately.

ENACTED this 24th day of September, 2007, Bulalacao, Oriental Mindoro.


