ORDINANCE NO. 08-03-078

AN ORDINANCE DECLARING A MORATORIUM ON THE MASSIVE PRODUCTION AND TRANSPORT OR SHIPMENT OF WOOD CHARCOAL EMANATING FROM THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO EFFECTIVE MARCH 10, 2008 UNTIL THE APPROVAL OF THE PROPOSED ESTABLISHMENT OF THE ULINGAN CENTER AT THIS MUNICIPALITY

"WHEREAS, there are several clamors from among different sectors calling for the immediate banning of massive production and exportation of wood charcoal explaining the ill-effects of the activity against society and Mother Nature;

"WHEREAS, balancing the ecological arguments vis-a-vis the need to provide source of income to the inhabitants, the establishment of "Ulingan Centers" was conceived as an alternative;

"WHEREAS, this Sanggunian intends to have a thorough and comprehensive study of the issue as it tries to appreciate and see both sides of the coin;

NOW THEREFORE; for and in consideration of the foregoing premises, and upon motion of Councilor Senen C. Familara duly seconded by Councilor Rosalinda M. Cabagay;

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to promote the protection, conservation and preservation of the environment and balance ecology, it is hereby declared that a moratorium for the massive production and transport or shipment of wood charcoal emanating from the Municipality of Bulalacao, Oriental Mindoro effective March 10, 2008 until the approval of the proposed establishment of the Ulingan Center at this Municipality shall be imposed;

SEC. 2. The moratorium herein imposed shall take effect on March 10, 2008 and shall only cease its application until the establishment of the proposed Ulingan Center is approve by the Sangguniang Bayan and duly reviewed by the Sangguniang Panlalawigan;


SEC. 3. All shippers, traders, businessmen and producers engaged in this trade or activity found to be violating this ordinance shall be punished by confiscation of their goods or merchandise (wood charcoal) and shall not bar the government from further prosecuting the offender for violating any applicable laws, ordinances, rules and regulations;


SEC. 4. The Municipal Treasurer or his duly authorized representative shall conduct inspection and accounting of the confiscated goods or merchandise (wood charcoal) to determine the volume of the same. The Municipal Treasurer shall likewise promulgate the necessary rules and regulations for the proper disposal or sale of the confiscated merchandise or goods. Payments for the sale of confiscated merchandise shall be made with that Office and corresponding official receipts shall be issued thereto. All moneys collected as payments shall be accrued to the general fund of the Municipality;


SEC. 5. All ordinances inconsistent hereof are hereby repealed, modified accordingly;


SEC. 6. This Ordinance shall take effect immediately after its approval in accordance with law..


