SPECIAL ORDINANCE SUSPENDING SEKSIYON 2 OF KAUTUSAN BLG. 11-09-115, ENTITLED "KAUTUSANG NAGTATAKDA NG MGA ALITUNTUNIN AT REGULASYON SA PAG-UULING SA NASASAKUPAN NG BAYAN NG BULALACAO, SILANGANG MINDORO" UNTIL DECEMBER 31, 2011

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Implementation of Seksiyon 2 of Kautusan Blg. 11-09-115, entitled "Kautusang nagtatakda ng mga alituntunin at regulasyon sa pag-uuling sa nasasakupan ng Bayan ng Bulalacao, Silangang Mindoro" prohibiting the shipment or transport of wood charcoal outside of this Municipality is hereby suspended until December 31, 2011;

SEC. 2. This Special Ordinance shall take effect immediately.






