SPECIAL ORDINANCE NO. 11-07-35

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR AND THE MUNICIPAL TREASURER TO ENROLL TO THE ELECTRONIC FILING AND PAYMENT SYSTEM (eFPS), THE E-SERVICES OF THE BUREAU OF INTERNAL REVENUE WHICH ALLOW TAXPAYERS A PAPERLESS TAX FILING AND CONVENIENT PAYMENT OF TAX DUES UTILIZING THE INTERNET FACILITY

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, Engr. Ernilo C. Villas and the Municipal Treasurer, Nachor S. Cabagay are hereby authorized to enroll in the Electronic Filing and Payment System (eFPS), the e-Services of the Bureau of Internal Revenue which allow taxpayers a paperless tax filing and convenient payment of tax dues utilizing the internet facility;


SEC. 2. This special ordinance shall take effect immediately.

ENACTED this 11th day of July, 2011, Bulalacao, Oriental Mindoro.


