**SPECIAL ORDINANCE NO. 12-11-26**

**SPECIAL ORDINANCE RATIFYING THE CONTRACT ENTERED INTO ON NOVEMBER 15, 2012 BY AND BETWEEN THE MUNICIPAL MAYOR WITH MR. DANNY M. CERVAS GRANTING THE LATTER THE EXCLUSIVE RIGHT TO OPERATE THE PARKING AREA FOR FEE SITUATED IN BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The contract entered into on November 15, 2012 by and between Engr. Ernilo C. Villas, Municipal Mayor with Mr. Danny M. Cervas granting the latter the exclusive right to operate the parking area for fee situated in Barangay Campaasan, Bulalacao, Oriental Mindoro stipulating therein terms and conditions such as the amount of fee which shall be in accordance with Ordinance No. 97-02-001 and the new Revenue Code; duties and obligations of the contracting parties and the effectivity which shall begin on November 15, 2012 until November 15, 2013 is hereby ratified;


**SEC. 2.** This Special Ordinance shall take effect immediately.




