### ORDINANCE NO. 15-06-152

**AN ORDINANCE ESTABLISHING THE ANIMAL BITE AND  
TREATMENT CENTER IN THE MUNICIPALITY OF BULALACAO,  
PROVINCE OF ORIENTAL MINDORO AND APPROPRIATING FUNDS  
THEREFOR**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao,  
Oriental Mindoro

**SECTION 1.** The Animal Bite and Treatment Center (ABTC) in the  
Municipality of Bulalacao, Province of Oriental Mindoro is hereby  
established.

**SEC. 2. Duties and Functions.** The ABTC shall undertake the  
following responsibilities:

- A. Immediate medical case management of victims bitten by dogs,  
cats, snakes and other rabid or venomous animals, free of any  
charge;
- B. Referral to other medical institutions for complicated and high-  
risk cases;
- C. Referral to Municipal Social Welfare and Development Office  
and other similar offices for any possible financial assistance;

- D. Research on the development of effective preventive strategies;
- E. Recommend to Municipal Rabies Control Committee, Municipal Health Board and Sangguniang Bayan, policies and rules that must be adopted or promulgated to ensure effective and efficient operation of ABTC.









**SEC. 3. Operation.** The ABTC shall be operated under the supervision of the Municipal Health Officer and shall be manned by duly designated health personnel who must have satisfactorily completed necessary training and seminar and who must have satisfied the qualifications.

**SEC. 4. Funding.** The Local Government Unit of Bulalacao through the recommendation of Municipal Health Board and Municipal Health Office shall appropriate funds for the operation and maintenance of ABTC in its Annual Budget starting FY 2016 and every year thereafter.

**SEC. 5. Repealing Clause.** Any existing ordinance or section thereof contrary to the provisions and intents of this Ordinance is deemed, repealed or amended upon approval of this Ordinance.

**SEC. 6. Effectivity.** This Ordinance shall take effect immediately and shall be posted in conspicuous places within the agency and in barangay halls.
