SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF SALINTUBIG PROJECT IN BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO




