ORDINANCE NO. 11 – 09 – 116

IMPOSING MUNICIPAL FISHPORT USERS FEE PER FISH BOX CONTAINING FISH FOR SHIPMENT UPON OWNERS OR OPERATORS OF VEHICLES ENGAGED IN THE TRANSPORT OF FISH OR SIMILAR MARINE PRODUCE

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There shall be collected from owners or operators of vehicles engaged in the transport of fish or similar marine products to pay the Municipal Fishport Users Fee prescribed hereunder;

SIZES OF BOX	PRICE/BOX
a. 40 kls. of fish -	Php20.00
b. 60 kls. of fish -	30.00
c. 90 kls. of fish -	45.00
d. 200 kls. of fish -	100.00

SEC. 2. The fee imposed in this ordinance shall be paid to the Municipal Treasurer or his duly authorized representative prior to the issuance of the Mayors' Permit;


SEC. 3. Penalty. Any violation of this ordinance shall be punished by a fine of not less than One Thousand Pesos (Php1,000.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and an imprisonment at the discretion of the Court;




SEC. 4. Effectivity. This ordinance shall take effect immediately.


