## SPECIAL ORDINANCE NO. 12-02-07

**SPECIAL ORDINANCE TEMPORARILY CLOSING TEMPLANZA TO ATIENZA TO BENDOLO AND PANTILO STREETS IN BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO STARTING FROM FEBRUARY 20, 2012 TO MARCH 5, 2012**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** In order to accommodate the selling of goods, merchandise, foodstuffs, commodities or articles of commerce by transient businessmen or traders to the general public in celebration of this year's town fiesta, Templanza to Atienza to Bendolo and Pantilo Streets in Barangay Poblacion, Bulalacao, Oriental Mindoro are hereby temporarily closed starting from February 20, 2012 to March 5, 2012;


**SEC. 2.** Any person found violating this Ordinance shall suffer the penalty of six (6) months imprisonment or shall be fined by an amount of Two Thousand Five Hundred Pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court;




SEC. 3. This Special Ordinance shall take effect immediately.
