### ORDINANCE NO. 11-06-112

#### AN ORDINANCE GRANTING FREE REGISTRATION FEE IN THE AFFIDAVIT TO USE THE SURNAME OF INDIGENT MANGYAN FATHER BY HIS OWN CHILD OR CHILDREN

**SPONSOR:** Councilor Eduardo C. Acheron  
**CO-SPONSORS:** Councilor Guillermo G. Salas, Jr.  
Councilor Senen C. Familara

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** It is hereby authorized to grant free registration fee in the affidavit to use the surname of indigent mangyan father by his child or children; provided, it is supported by Certificate of Indigency issued by the Municipal Social Welfare and Development Office, Bulalacao, Oriental Mindoro and Certificate of Tribal Membership from the National Commission on Indigenous People.

**SEC. 2.** All ordinances inconsistent hereof are hereby repealed, modified accordingly.


**SEC. 3.** Any violation hereof shall be punished by a fine of Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not exceeding Six (6) months or both such fine and imprisonment at the discretion of the Court.


**SEC. 4. Effectivity.** This Ordinance shall take effect immediately.




